In consideration for the aforementioned services provided by Little River Casino Resort,

_____, herein called the "Purchaser", agrees to

pay Little River Casino Resort the amount as specified above.

In addition, the "Purchaser" agrees to the following terms and conditions:

- 1) To maintain staff at the display for the entire duration of the show.
- 2) To conduct your activities in such a manner that does not disturb, or is in any way detrimental to the other vendors. All display areas must be maintained in a clean and orderly fashion.
- 3) To NOT remove any parts of your display until 3:00 p.m. unless otherwise notified by Little River Casino Resort. Failure to adhere to this condition could jeopardize your privilege to participate in subsequent shows.
- 4) Exhibitors must adhere to all city and state fire regulations.
- 5) Little River Casino Resort shall not be held liable for any damage caused by or related to the use of electricity at the show.
- 6) Little River Casino Resort is not responsible for any damages to the "Purchaser" in the event that the Bridal Show is unable to be held due to weather conditions, accidents, riot, Acts of God or any other reasonable events beyond the control of Little River Casino Resort that may prevent the Bridal Show from taking place. No fees shall be returned if the show is cancelled due to any of the aforementioned reasons.
- 7) Vendors are not permitted to "share" booths with any other business. One business per booth.
- 8) Bridal Show Lead List: The use of the bride registration list for any purpose whatsoever, is restricted to participating businesses only. Any participating business that uses or shares this list in any manner whatsoever beyond the purposes of the participating businesses' own marketing, shall pay a penalty of \$5000 to Little River Casino Resort.
- 9) **Vendors selling merchandise will be required to provide a Concessionaire's Tribal Tax Registration (attached). It must be completed and returned with your show agreement to Wisser Productions no later October 7, 2010.**
- 10) The Undersigned exhibitor agrees that the printed matter on both front and back of this contract has been read and that the terms and conditions set forth therein are fully understood and shall constitute a binding contract when this instrument is signed by both parties (faxed/electronic signatures are accepted as originals).
